2. MANNER OF ELECTION :


- The Elections will be held as per the provisions of the Memorandum of Association of IPSF and the guidelines of **National Sports Development Code 2011**.
- The election in the event contest shall be through secret ballot or raise by hand only.
- Every member of the State Association / UT/ Unit who is in the good standing in accordance of Memorandum of Association and Byelaws of Indian Pencak Silat Federation, enlisted in the Electoral College to participate in the elections. State Pencak Silat Association-02 (Two); Union Territory-02 (Two), representative each shall be entitled.
- Representatives should carry necessary identity card such as Aadhar card indicating the belongingness from the concerned State/ UT/ Unit. Based on the same, Entry-card for IPSF-Elections will be issued.
- Duly filled-in Nomination forms in Form No:2 to be delivered to the Returning Officer, as detailed under the following Schedule.
- Each candidate shall be entitled to be nominated by not more than 2 nomination papers.
- No person shall be eligible to nominate more than one candidate for the same post, either as Proposer or Secunder.
