### **3. MANNER OF ELECTION :**

- The Elections will be held as per the provisions of the Memorandum of IPSF and the guidelines of **National Sports Development Code 2011.**
- The election in the event contest shall be through Secret Ballot or raise by hand only.
- Every **member** of the State Association / UT's who is in the good standing in accordance of **Memorandum** of Association and Byelaws of Indian Pencak Silat Federation, enlisted in the Electoral College to participate in the elections. State Pencak Silat Association-02 (Two); Union Territory-02 (Two), representative each shall be entitled.
- Representatives should carry necessary identity card such as Aadhar card indicating the belongingness from the concerned State/ UT. Based on the same, Entry-card for IPSF-Elections will be issued.
- Duly filled-in Nomination forms in Form No:2 to be delivered to the Returning Officer, as detailed under the following Schedule.
- Each candidate shall be entitled to be nominated by not more than 2 nomination papers.
- No person shall be eligible to nominate more than one candidate for the same post, either as Proposer or Secunder.



4. **GRIEVANCES** :- Any grievances related to the election shall be addressed to the returning officer directly.


